GOP-Led Committee Quashes Bid to Subpoena Four Bank CEOs

This table shows a vote by the GOP-led House Judiciary Committee on Sept. 17, 2025, to quash a Democratic bid to subpoena CEOs of four banks that did business with Jeffrey Epstein's criminal ring — Jamie Dimon of JP Morgan Chase, Brian Moynihan of Bank of America, Christian Sewing of Deutsche Bank and Robin Vince of Bank of New York. Their banks filed “suspicious activity” reports with the Department of the Treasury on at least \$1.5 billion in Epstein-related business.
