This table shows a bipartisan vote by the House Committee on Oversight and Government Reform to subpoena Atty. Gen. Pam Bondi over the administration's shirking of the Epstein Files Transparency Act. At the time of the vote March 4, 2026, the administration had released about half of the millions of documents, photos, emails, videos and other evidence collected in federal and state probes of Epstein over decades. The act requires full and immediate disclosure of the files.
